**UPON** reviewing and considering current international, national and regional  
market and related conditions;

**AND UPON** it appearing to the Commission that:

- 1) An increase in all gasoline prices in both the dealer and consumer  
schedules of 1.0 cents per litre (cpl);
- 2) An increase in the diesel prices in both the dealer and consumer  
schedules of 1.0 cpl; and
- 3) A continuation of the furnace fuel and stove oil prices currently in effect  
in the consumer schedule;

will result in prices that are just and reasonable;

**AND UPON** receiving:

- 1) The application of Irving Energy Distribution and Marketing (Irving) on  
December 01, 2020 for a decrease of 0.1 cents per litre (cpl) in its  
propane pricing schedule based on decreased costs;
- 2) The application of Kenmac Energy Inc. (Kenmac) on November 30, 2020  
for a decrease of 0.5 cpl in its propane pricing schedule based on  
decreased costs;
- 3) The application of Superior Plus Inc. (Superior) on December 01, 2020  
for an increase of 0.2 cpl in its propane pricing schedule based on  
increased costs;
- 4) The application of Parkland Fuel Corporation (Island Petroleum) on  
December 01, 2020 for an increase of 0.5 cpl in its propane pricing  
schedule based on increased costs; and
- 5) The application of Noonan Petroleum Ltd. (Noonan) on November 30,  
2020 for a decrease of 0.5 cpl in its propane pricing schedule based on  
decreased costs;

**AND UPON** it also appearing to the Commission that:

- 1) A decrease of 0.1 cpl in Irving's propane schedule;
- 2) A decrease of 0.5 cpl in Kenmac's propane schedule;
- 3) An increase of 0.2 cpl in Superior's propane schedule;
- 4) An increase of 0.5 cpl in Island Petroleum's propane schedule; and
- 5) A decrease of 0.5 cpl in Noonan Petroleum's propane schedule;

will result in prices that are just and reasonable;

**NOW THEREFORE**, pursuant to the *Island Regulatory and Appeals Commission Act* and *the Petroleum Products Act*,

**IT IS ORDERED THAT**

1. the prices contained in the attached Dealer Petroleum Prices Schedule shall be effective 12:01 a.m. on Friday, December 04, 2020;
2. the prices contained in the attached Posted Consumer Petroleum Prices Schedule shall be the maximum prices charged by the respective licensee, effective 12:01 a.m. on Friday, December 04, 2020;
3. the attached dealer prices, with H.S.T. added, shall be indicated on all documents accompanying deliveries of these products;
4. effective 12:01 a.m. Friday, December 04, 2020, the maximum propane prices charged by:
  - a. Irving Energy Distribution and Marketing be in accordance with Appendix "A" to this Order;
  - b. Kenmac Energy Inc. be in accordance with Appendix "B" to this Order;
  - c. Superior Plus Inc. be in accordance with Appendix "C" to this Order;
  - d. Parkland Fuel Corporation be in accordance with Appendix "D" to this Order; and
  - e. Noonan Petroleum Ltd. be in accordance with Appendix "E" to this Order;
5. the propane prices approved herein shall appear on all invoices covering sales or deliveries of propane; and
6. the prices determined in this Order, with adjustments resulting from tax changes only, shall remain in effect until otherwise ordered by the Commission.

**NOTICE:**

**Section 58 of the *Petroleum Products Act* reads as follows:**

*58. Where any person has the status of a party or is an intervenor in any hearing before the Commission, he is entitled*

*(a) to appeal the decision of the Commission to the Court of Appeal; and*

*(b) to participate as a party in the hearing of an appeal.*

*and an appeal shall be on a question of law or jurisdiction only and be governed by section 13 of the *Island Regulatory and Appeals Commission Act*.*

**Sections 13 (1) and (2) of the *Island Regulatory and Appeals Commission Act* provide as follows:**

*13.(1) An appeal lies from a decision or order of the Commission to the Court of Appeal upon a question of law or jurisdiction.*

*(2) The appeal shall be made by filing a notice of appeal in the Court of Appeal within twenty days after the decision or order appealed from and the rules of court respecting appeals apply with the necessary changes.*
