# Re: Restructuring proposal for The Rural Municipalities of Ellerslie-Bideford and Lady Slipper

The Rural Municipalities of Ellerslie-Bideford and Lady Slipper have submitted an application for restructuring pursuant to Section 15 of the Municipal Government Act.

Pursuant to Section 15(3) of the Municipal Government Act, even where a proposal to restructure a rural municipality will not result in a municipality that meets the criteria for a city or town, the Minister may approve the submission of the proposal to the Commission for consideration.

Dear Minister Brown,

The Councils of Lady Slipper and Ellerslie-Bideford would like to amalgamate into one municipality named the Rural Municipality of Central Prince. In the summer of 2017 flyers were mailed out to residents of both municipalities informing residents of the upcoming changes occurring due to the new municipal government act that was being presented by the provincial government at the time and looking for input into amalgamation. On April 24, 2018 we held a joint public meeting with 31 residents present out of over 1100 residents in our combined area. The general consensus was in favor of amalgamation.

We have taken into consideration the principles, standards and regulations of the new municipal government act and believe that we are more financially viable together as a rural municipality providing limited services as such and will not be hindering anyone else with this amalgamation.

Our municipal office will be located at 1180 Ellerslie Road and is assessible. We are already both members of a joint EMO with the municipalities of Tyne Valley and Lot 11 and Area and will continue to be a member under the new municipality.

It is our intent to have one mayor and six councilors with two tax areas: (1) Lady Slipper with a commercial tax rate of \$.09 and a non-commercial tax rate of \$0.09 and (2) Ellerslie-Bideford with a commercial tax rate of \$0.14 and a non-commercial rate of \$0.14. We will be financing our Official Plan and Zoning and Development Bylaw with funding provided by the Gas Tax Fund by 2022.

Please consider the attached application for the amalgamation of the Rural Municipalities of Lady Slipper and Ellerslie –Bideford.

General Notes on restructured municipality proposal.

- 1. Neither existing municipalities have any debt
- 2. There will be 1 ward with 2 different tax areas. 4 tax rates (2 for each of the existing municipalities- commercial and non-commercial)
- 3. We ask that the Election bylaw for Ellerslie-Bideford be accepted as a bylaw for the new municipality so that an election can be held in November for the new municipality.
- 4. We ask that the EMO bylaw for Ellerslie-Bideford be accepted as a bylaw for the new municipality as Ellerslie-Bideford and Lady Slipper already have a joint EMO organization in place with our neighbouring municipalities of Tyne Valley and Lot 11 and Area. This would enable the existing EMO to continue functioning.
- 5. Funds in the general bank accounts of both municipalities will be used to pay down expenses in their new corresponding tax areas until they are exhausted. Lady slipper EMO bank account will remain as an emergency fund to be used for the residents in the lady slipper tax area if or when needed. Funds in the Ellerslie-Bideford Gas Tax account will be drawn down by projects that have already been approved over the next two years.
- 6. General expenses to maintain assets (i.e. sports fields, picnic site) will be paid by the residents of the corresponding tax area, except for the operating and maintenance expenses of the municipal office building located at 1180 Ellerslie Road which will be allocated on a per resident basis.
- 7. Costs such as fire dues, street lights, student salaries, cemetery costs that occur within only one tax area will be paid by residents of that tax area, all other expenses (i.e. administration, auditing, legal, banking, insurance) will be allocated on a per resident basis.


