- v. All witness lists and 'will-say' statements, on or before - **Tuesday, January 20, 2026, at 4:00 p.m.** No additional witnesses will be permitted to be called at the hearing after this deadline.
- vi. Appellant's further written submissions, on or before - **Tuesday, January 20, 2026, at 4:00 p.m.**
- vii. Respondent and Developer further written submissions in response, on or before - **Tuesday, January 27, 2026, at 4:00 p.m.**
- viii. Any miscellaneous documents or exhibits not previously referred to, on or before - **Tuesday, January 27, 2026, at 4:00 p.m.**
- ix. In the event that an expert witness elects to testify via Zoom audio and video, the Commission must be advised not later than - **Tuesday, January 27, 2026, at 4:00 p.m.**
