## **NOTICE OF INTENTION TO PARTICIPATE**

- 1. The Convenience Industry Council of Canada (CICC) seeks leave to intervene in this proceeding as an Added Party Intervener.
- 2. The CICC is a national, not-for-profit trade organization representing retail owners, operators and suppliers in Canada's convenience channel. The convenience store industry is the largest retailer of motor fuels in Prince Edward Island in terms of both volume and number of retail sites.
- 3. The CICC submits that this proceeding addresses issues and touches upon matters directly affecting its membership, and therefore it has interests in this proceeding, including:
  - a. PEI petroleum markets and the benchmark price for gasoline and diesel;
  - b. Motor fuels retail margins; and
  - c. The incorporation of Clean Fuel Regulations (CFR) into the IRAC motor fuel pricing model.
- 4. Over a number of years, the CICC and the Atlantic Canada division of the CICC, formerly the Atlantic Convenience Stores Association, have been recognized by regulatory authorities in New Brunswick, Nova Scotia and Newfoundland and Labrador as an intervener in public and paper hearings related to motor fuels. The CICC has also made commentary submissions to IRAC with respect to retail motor fuels margin reviews.
