## 2 site visits:

April 25<sup>th</sup> – Gisele Bernard (Community Development Officer from Rural & Regional Development) and 3 members from Home Care and Colette Gallant, CAO met for a short visit. The Group from Home Care was very happy with the progress and layouts.

May 5<sup>th</sup> – Gilles Arsenault, (MLA for District 24, Évangéline–Miscouche), Gisele Bernard (Community Development Officer from Rural & Regional Development), David Arsenault, Larry Llewllyn (Wellington Construction) and Colette Gallant, CAO met for a short visit. Gilles Arsenault was very happy and impressed of all the changes and potential use for the future of the building in the community.

Completing renovation date for Open house – As per Wellington Construction, we are now looking at a completing date of late June.(tentative open house date – Saturday June 8<sup>th</sup>) Colette Gallant will speak with the owners of Magasin Acadien for possibly catering this event.

#### Other:

IRAC - Phil Leblanc has reached IRAC and completed the request to see on the possible increase of our Sewer amount for next year. They require a copy of our Bylaw and the last 2 financial statements. Yolande Gallant proposed we continue with this. Charlene Richard seconded this request.
