Ms. Gillis,

We have been advised that, on July 16, council gave first reading and approval to Bylaw #2025R – A Bylaw to Repeal Bylaw #2024-14-A02. If council adopts Bylaw #2025R, Bylaw #2024-14-A02 will be repealed. If Bylaw #2024-14-A02 is repealed, the appellants' appeal against council's decision to adopt this bylaw will be rendered moot in the technical sense. We are advised that second reading may take place as early as this Wednesday.

We note that, even if the appellants' appeal against council's decision to adopt Bylaw #2024-14-A02 is rendered moot, the appellants' attempt to appeal against council's decision to amend the Official Plan will remain. As you know, the Municipality's position is that the Commission has no jurisdiction to hear an appeal against a decision to amend an official plan.

We bring this information to the Commission's attention so that the Commission may consider the allocation of its resources to this appeal process over the coming weeks. In our view, these recent developments may lend additional importance to determining which of the remaining grounds of appeal, if any, fall within the Commission's jurisdiction. We can be available for an all-party call if requested. In the meantime, an index is attached.
