Thank you for participating in yesterday's technical session with respect to the above-noted matter.

At this time, the Commission intends to make a determination with respect to matters of confidentiality, specifically as they relate to the Amended Application and the closed session of the technical session.

The Commission's approach to confidentiality begins from the principle of transparency in its proceedings. In accordance with Rule 53 of the Commission's Rules of Practice and Procedure, a party requesting confidentiality must demonstrate why disclosure of the information would cause specific harm, and why that harm outweighs the public interest in disclosure.

The Applicant, Maritime Electric Company, Limited ("MECL"), is directed to submit a formal request for confidentiality by no later than **3:00 p.m. on Tuesday, September 16, 2025**. MECL's request for confidentiality must provide all information required by the Commission's *Rules of Practice & Procedure*, and must be served on the interveners and filed with the Commission in accordance with the *Rules*.



If any intervener intends to reply specifically to MECL's September 16th request for confidentiality, they must do so by no later than **12:00 p.m. on Thursday, September 18, 2025.**
