Response to the Procedural Direction issued in this matter on March 7, 2025 dealing with the Letters of Support on behalf of DP Murphy Inc.

Letters of support indicate that this gas station will be used for parking big trucks in the event the bridge closes to high sided traffic. There is parking at property number #848283 owned by the provincial government which is close to the same location as the proposed station. The Confederation Bridge website states the following: "Safe and convenient staging/parking areas are located on both sides of the Confederation Bridge. During wind events, drivers in Prince Edward Island are encouraged to utilize the rest area located at the corner of Industrial Drive and Dickie Road in Borden-Carleton. This lot is in close proximity to nearby facilities including washrooms, Tim Hortons, and Gateway Village."

As DP Murphy Inc. said at the town of Borden-Carleton meeting this would not be a "truck stop" but the letters of support that have been provided seem to suggest different.
