Based on my review, it is my understanding that you are requesting the Commission hold your appeal in abeyance while the civil action proceeds in the Supreme Court. Is this correct? If so, please advise. We will then share your letter and request with the other parties to the appeal, being the Minister and Developer, Mr. Banks, and seek their position on the abeyance request. The Commission will then determine one way or the other how the appeal will proceed.

With respect to your comments about safeguarding the appeal process before the Commission, the Commission is a statutory tribunal and only has jurisdiction and authority over its own process. We have Rules of Practice and Procedure (link) designed, in part, to ensure all parties to a proceeding before the Commission are afforded a reasonable opportunity to be heard in this forum.
