




GENERAL NOTES:

- 1. COORDINATES DEPICTED ON THIS PLAN ARE REFERENCED TO THE PRINCE EDWARD ISLAND DOUBLE STEREOGRAPHIC PROJECTION BASED ON THE NAD83 (CSRS) EPOCH (2010) REALIZATION; AZIMUTHS DEPICTED ON THE PLAN ARE PRINCE EDWARD ISLAND GRID NORTH AND ARE
- DERIVED FROM REAL TIME KINEMATIC (RTK) AND.OR STATIC GNSS OBSERVATIONS REFERENCED TO THE PRINCE EDWARD ISLAND ACTIVE CONTROL NETWORK (SMARTNET NORTH AMERICA); 3. LINEAR MEASUREMENTS DEPICTED ON THIS PLAN ARE GRID MEASUREMENTS IN METRES
