**That the request to accept Heritage Board's recommendation and designate 10 Prince Street (PID#336321) as a Heritage Resource per section 3.3 of the Heritage Preservation Bylaw and include the property on the Inventory of Designated Heritage Resources for the City of Charlottetown be approved.**

SCHEDULE "A"

ALL THAT TRACT, piece and parcel of land situate, lying and being in Charlottetown, in Queens County, Province of Prince Edward Island, and being part of Lot Number 21 in the first hundreds of Town Lots in Charlottetown, aforesaid, bounded and described as follows, that is to say

COMMENCING at the angle of Prince and Water Streets, on the North side of Water Street and on the East side of Prince Street and running along Prince Street Northwardly 42 Feet;

THENCE Eastwardly 84 Feet to Town Lot Number 22 in the said first hundreds;

THENCE Southwardly along the division line of Town Lots Numbers 21 and 22 for the distance of 42 Feet to Water Street aforesaid, and
