Notice of Application

Maritime Electric Open Access Transmission Tariff Changes

Maritime Electric Company, Limited has filed an application with the Commission seeking approval of changes to certain charges under its Open Access Transmission Tariff (OATT).

Background

The OATT, approved August 1, 2018, Order UE18-05, defines the terms, conditions and price by which third parties can access Maritime Electric's transmission system.

Maritime Electric is required to apply, at least once every three years, for approval of its transmission revenue requirements. In the application, Maritime Electric seeks approval of its transmission revenue requirements for 2021.

Details

Maritime Electric is seeking approval to change a number of the charges payable under its OATT, including the charges for point-to-point transmission service and network transmission service. A complete list of all proposed changes can be found in the application.

How to comment and ask questions

The Commission invites public input on the application. Written comments must be received by **Wednesday, September 15, 2021**.

Anyone seeking further information may submit written questions to Maritime Electric, with a copy to the Commission, by **Friday, August 27, 2021**. Maritime Electric must respond to all written questions, with a copy to the Commission, by **Wednesday, September 8, 2021**.

Anyone wishing to intervene in the application may apply to the Commission for intervener status following the Commission's Rules of Practice & Procedure. Written requests must be received by 4:00 p.m., **Wednesday, September 15, 2021**.

All questions and comments will be made public and posted on the Commission website.

A public hearing will not be held unless the Commission determines it is necessary. If a public hearing is to be held, a Notice of Hearing will be published. Otherwise, the Commission will issue an Order on the application which will be posted on the Commission website at www.irac.pe.ca/electric.
