

OVERVIEW OF THE APPLICATION:

- 1. On July 6, 2022, Maritime Electric Company, Limited ("MECL") filed an application with the Prince Edward Island Regulatory and Appeals Commission (the "Commission") seeking approval of the Company's 2023 Annual Capital Budget (the "Application").
- 2. Following receipt of the application, the Commission gave public notice of the Application through a publication in local newspapers and on the Commission website. Interested members of the public were given the opportunity to issue questions to MECL, and submit comments to the Commission.
- 3. The Commission issued two rounds of interrogatories to MECL and MECL responded to the interrogatories on December 6, 2022 and March 28, 2023 respectively.
- 4. As the Commission's review of the Application is ongoing, MECL has requested interim approval of certain 2023 capital projects, pending the Commission's final decision with respect to the entirety of the Application.
- 5. The Commission has considered MECL's request and has determined that an Order for interim approval of certain capital projects is appropriate in the circumstances.

ORDER:

The Commission Orders as follows:

- 1. The following 2023 capital projects are approved on an interim basis, pending the Commission's final decision with respect to the entirety of the Application.
- 2. MECL is authorized to make capital expenditures not exceeding the amounts set forth herein.
