**UPON** reviewing and considering current international, national and regional market and related conditions;

#### **AND UPON** it appearing to the Commission that:

- 1) A decrease in the gasoline prices currently in effect in both the dealer and consumer schedules of 3.0 cents per litres (cpl);
- 2) A decrease in the diesel prices currently in effect in both the dealer and consumer schedules of 15.0 cpl; and
- 3) A decrease in the furnace fuel and stove oil prices currently in effect in the consumer schedule of 19.0 cpl;

will result in prices that are just and reasonable;

#### **AND UPON** receiving:

- The application of Irving Energy Distribution and Marketing (Irving) on November 14, 2022, for an increase of 1.2 cpl in its propane pricing schedule based on increased costs;
- The application of Superior Plus Inc. (Superior) on November 15, 2022, for an increase of 0.8 cpl in its propane pricing schedule based on increased costs;
- 3) The application of Kenmac Energy Inc. (Kenmac) on November 15, 2022, for an increase of 0.5 cpl in its propane pricing schedule based on increased costs;
- 4) The application of Parkland Fuel Corporation (Parkland) on November 14, 2022, for no change in its propane pricing schedule; and
- 5) The application of Noonan Petroleum Ltd. (Noonan) on November 14, 2022, for an increase of 0.5 cpl in its propane pricing schedule based on increased costs;

#### **AND UPON** it also appearing to the Commission that:

- 1) An increase of 1.2 cpl in Irving's propane schedule;

- 4. effective 12:01 a.m. Friday, November 18, 2022, the maximum propane prices charged by:
  - a. Irving be in accordance with Appendix "A" to this Order;
  - b. Superior be in accordance with Appendix "B" to this Order;
  - c. Kenmac be in accordance with Appendix "C" to this Order;
  - d. Parkland be in accordance with Appendix "D" to this Order; and
  - e. Noonan be in accordance with Appendix "E" to this Order;
- 5. the propane prices approved herein shall appear on all invoices covering sales or deliveries of propane; and
- the prices determined in this Order, with adjustments resulting from tax changes only, shall remain in effect until otherwise ordered by the Commission.
