**UPON** reviewing and considering current international, national and regional market and related conditions;

#### **AND UPON** it appearing to the Commission that:

- 1) An increase in the regular gasoline prices currently in effect in both the dealer and consumer schedules of 2.0 cents per litres (cpl);
- 2) An increase in the premium gasoline prices currently in effect in both the dealer and consumer schedules of 2.0 cpl;
- No change in the diesel prices currently in effect in both the dealer and consumer schedules; and
- 4) An increase in the furnace fuel and stove oil prices currently in effect in the consumer schedule of 2.0 cpl;

will result in prices that are just and reasonable;

#### **AND UPON** receiving:

- The application of Irving Energy Distribution and Marketing (Irving) on June 25, 2024, for an increase of 1.4 cpl in its propane pricing schedule based on increased costs;
- 2) The application of Superior Plus Inc. (Superior) on June 25, 2024, for an increase of 0.7 cpl in its propane pricing schedule based on increased costs;
- 3) The application of Kenmac Energy Inc. (Kenmac) on June 25, 2024, for an increase of 2.4 cpl in its propane pricing schedule based on increased costs:
- 4) The application of Parkland Fuel Corporation (Parkland) on June 24, 2024, for a decrease of 1.3 cpl in its propane pricing schedule based on decreased costs; and
- 5) The application of Noonan Petroleum Ltd. (Noonan) on June 25, 2024, for an increase of 2.4 cpl in its propane pricing schedule based on increased costs;

#### **AND UPON** it also appearing to the Commission that:

- 1) An increase of 1.4 cpl in Irving's propane schedule;
- 2) An increase of 0.7 cpl in Superior's propane schedule;
- 3) An increase of 2.4 cpl in Kenmac's propane schedule;
- 4) A decrease of 1.3 cpl in Parkland's propane schedule; and
- 5) An increase of 2.4 cpl in Noonan's propane schedule;

will result in prices that are just and reasonable;

- 2. the prices contained in the attached Maximum Consumer Petroleum Prices Schedule shall be the maximum prices charged by the respective licensee, effective 12:01 a.m. on Friday, June 28, 2024;
- 3. the attached dealer prices, with H.S.T. added, shall be indicated on all documents accompanying deliveries of these products;
- 4. effective 12:01 a.m. Friday, June 28, 2024, the maximum propane prices charged by:
  - a. Irving be in accordance with Appendix "A" to this Order;
  - b. Superior be in accordance with Appendix "B" to this Order;
  - c. Kenmac be in accordance with Appendix "C" to this Order;
  - d. Parkland be in accordance with Appendix "D" to this Order; and
  - e. Noonan be in accordance with Appendix "E" to this Order;
- 5. the propane prices approved herein shall appear on all invoices covering sales or deliveries of propane; and
- 6. the prices determined in this Order, with adjustments resulting from tax changes only, shall remain in effect until otherwise ordered by the Commission.
