UPON reviewing and considering current international, national and regional market and related conditions;

AND UPON it appearing to the Commission that:

- 1) A decrease in the regular gasoline prices currently in effect in both the dealer and consumer schedules of 1.5 cents per litres (cpl);
- 2) No change in the premium gasoline prices currently in effect in both the dealer and consumer schedules;
- 3) A decrease in the diesel prices currently in effect in both the dealer and consumer schedules of 0.5 cpl; and

- 5) The application of Noonan Petroleum Ltd. (Noonan) on November 12, 2024, for an increase of 5.2 cpl in its propane pricing schedule based on increased costs;

AND UPON it also appearing to the Commission that:

- 1) An increase of 1.8 cpl in Irving's propane schedule;

- 4. effective 12:01 a.m. Friday, November 15, 2024, the maximum propane prices charged by:
 - a. Irving be in accordance with Appendix "A" to this Order;
 - b. Superior be in accordance with Appendix "B" to this Order;
 - c. Kenmac be in accordance with Appendix "C" to this Order;
 - d. Parkland be in accordance with Appendix "D" to this Order; and
 - e. Noonan be in accordance with Appendix "E" to this Order;
- 5. the propane prices approved herein shall appear on all invoices covering sales or deliveries of propane; and
- 6. the prices determined in this Order, with adjustments resulting from tax changes only, shall remain in effect until otherwise ordered by the Commission.
