UPON reviewing and considering current international, national and regional market and related conditions;

AND UPON it appearing to the Commission that:

- No change in the regular gasoline prices currently in effect in both the dealer and consumer schedules;
- 2) An increase in the premium gasoline prices currently in effect in both the dealer and consumer schedules of 1.0 cents per litres (cpl);
- No change in the diesel prices currently in effect in both the dealer and consumer schedules; and
- 4) An increase in the furnace fuel and stove oil prices currently in effect in the consumer schedule of 4.9 cpl;

will result in prices that are just and reasonable;

AND UPON receiving:

- 4. effective 12:01 a.m. Friday, January 24, 2025, the maximum propane prices charged by:
 - a. Irving be in accordance with Appendix "A" to this Order;
 - b. Superior be in accordance with Appendix "B" to this Order;
 - c. Kenmac be in accordance with Appendix "C" to this Order;
 - d. Avenir be in accordance with Appendix "D" to this Order; and
 - e. Noonan be in accordance with Appendix "E" to this Order;
- 5. the propane prices approved herein shall appear on all invoices covering sales or deliveries of propane; and
- 6. the prices determined in this Order, with adjustments resulting from tax changes only, shall remain in effect until otherwise ordered by the Commission.
