**UPON** reviewing and considering current international, national and regional market and related conditions;

**AND UPON** it appearing to the Commission that:

- 1) A decrease in the regular gasoline prices currently in effect in both the dealer and consumer schedules of 2.5 cents per litres (cpl);
- 2) A decrease in the premium gasoline prices currently in effect in both the dealer and consumer schedules of 2.5 cpl;
- 3) A decrease in the diesel prices currently in effect in both the dealer and consumer schedules of 2.5 cpl; and
- 4) A decrease in the furnace fuel and stove oil prices currently in effect in the consumer schedule of 2.5 cpl;

will result in prices that are just and reasonable;

**AND UPON** receiving:

- 1) The application of Irving Energy Distribution and Marketing (Irving) on April 11, 2025, for a decrease of 2.6 cpl in its propane pricing schedule based on decreased costs;
- 2) The application of Superior Plus Inc. (Superior) on April 15, 2025, for a decrease of 2.7 cpl in its propane pricing schedule based on decreased costs;
- 3) The application of Kenmac Energy Inc. (Kenmac) on April 14, 2025, for a decrease of 4.5 cpl in its propane pricing schedule based on decreased costs;
- 4) The application of Avenir Energy (Avenir) on April 15, 2025, for a decrease of 1.5 cpl in its propane pricing schedule based on decreased costs; and
- 5) The application of Noonan Petroleum Ltd. (Noonan) on April 14, 2025, for a decrease of 4.5 cpl in its propane pricing schedule based on decreased costs;

**AND UPON** it also appearing to the Commission that:

- 1) A decrease of 2.6 cpl in Irving's propane schedule;
- 2) A decrease of 2.7 cpl in Superior's propane schedule;
- 3) A decrease of 4.5 cpl in Kenmac's propane schedule;
- 4) A decrease of 1.5 cpl in Avenir's propane schedule; and
- 5) A decrease of 4.5 cpl in Noonan's propane schedule;

will result in prices that are just and reasonable;

**NOW THEREFORE**, pursuant to the *Island Regulatory and Appeals Commission Act* and the *Petroleum Products Act*,

**IT IS ORDERED THAT**

1. the prices contained in the attached Retail Dealer Pump Prices Schedule shall be effective 12:01 a.m. on Friday, April 18, 2025;
2. the prices contained in the attached Maximum Consumer Petroleum Prices Schedule shall be the maximum prices charged by the respective licensee, effective 12:01 a.m. on Friday, April 18, 2025;
3. the attached dealer prices, with H.S.T. added, shall be indicated on all documents accompanying deliveries of these products;
4. effective 12:01 a.m. Friday, April 18, 2025, the maximum propane prices charged by:
  - a. Irving be in accordance with Appendix "A" to this Order;
  - b. Superior be in accordance with Appendix "B" to this Order;
  - c. Kenmac be in accordance with Appendix "C" to this Order;
  - d. Avenir be in accordance with Appendix "D" to this Order; and
  - e. Noonan be in accordance with Appendix "E" to this Order;
5. the propane prices approved herein shall appear on all invoices covering sales or deliveries of propane; and
6. the prices determined in this Order, with adjustments resulting from tax changes only, shall remain in effect until otherwise ordered by the Commission.

**NOTICE:****Section 58 of the *Petroleum Products Act* reads as follows:**

*(a) to appeal the decision of the Commission to the Court of Appeal; and*

*(2) The appeal shall be made by filing a notice of appeal in the Court of Appeal within twenty days after the decision or order appealed from and the rules of court respecting appeals apply with the necessary changes.*
