UPON reviewing and considering current international, national and regional market and related conditions;

AND UPON it appearing to the Commission that:

- 1) A decrease in the regular gasoline prices currently in effect in both the dealer and consumer schedules of 2.5 cents per litres (cpl);
- 2) A decrease in the premium gasoline prices currently in effect in both the dealer and consumer schedules of 3.0 cpl;
- 3) A decrease in the diesel prices currently in effect in both the dealer and consumer schedules of 0.5 cpl; and
- 4) A decrease in the furnace fuel and stove oil prices currently in effect in the consumer schedule of 1.5 cpl;

will result in prices that are just and reasonable;

AND UPON receiving:

- The application of Irving Energy Distribution and Marketing (Irving) on October 14, 2025, for an increase of 0.1 cpl in its propane pricing schedule based on increased costs;
- 2) The application of Superior Plus Inc. (Superior) on October 14, 2025, for no change in its propane pricing schedule;
- The application of Kenmac Energy Inc. (Kenmac) on October 15, 2025, for a decrease of 0.8 cpl in its propane pricing schedule based on decreased costs;
- 4) The application of Avenir Energy (Avenir) on October 10, 2025, for an increase of 1.0 cpl in its propane pricing schedule based on increased costs; and
- 5) The application of Noonan Petroleum Ltd. (Noonan) on October 15, 2025, for a decrease of 0.8 cpl in its propane pricing schedule based on decreased costs;

AND UPON it also appearing to the Commission that:

- 1) An increase of 0.1 cpl in Irving's propane schedule;
- No change in Superior's propane schedule;
- 3) A decrease of 0.8 cpl in Kenmac's propane schedule;
- 4) An increase of 1.0 cpl in Avenir's propane schedule; and
- 5) A decrease of 0.8 cpl in Noonan's propane schedule;

- 3. the attached dealer prices, with H.S.T. added, shall be indicated on all documents accompanying deliveries of these products;
- 4. effective 12:01 a.m. Friday, October 17, 2025, the maximum propane prices charged by:
 - a. Irving be in accordance with Appendix "A" to this Order;
 - b. Superior be in accordance with Appendix "B" to this Order;
 - c. Kenmac be in accordance with Appendix "C" to this Order;
 - d. Avenir be in accordance with Appendix "D" to this Order; and
 - e. Noonan be in accordance with Appendix "E" to this Order;
- 5. the propane prices approved herein shall appear on all invoices covering sales or deliveries of propane; and
- 6. the prices determined in this Order, with adjustments resulting from tax changes only, shall remain in effect until otherwise ordered by the Commission.
