**UPON** reviewing and considering current international, national and regional market and related conditions;

#### **AND UPON** it appearing to the Commission that:

- 1) An increase in the regular gasoline prices currently in effect in both the dealer and consumer schedules of 1.0 cents per litres (cpl);
- 2) An increase in the premium gasoline prices currently in effect in both the dealer and consumer schedules of 0.5 cpl;
- 3) An increase in the diesel prices currently in effect in both the dealer and consumer schedules of 4.5 cpl; and
- 4) An increase in the furnace fuel and stove oil prices currently in effect in the consumer schedule of 4.0 cpl;

will result in prices that are just and reasonable;

#### **AND UPON** receiving:

- The application of Irving Energy Distribution and Marketing (Irving) on October 28, 2025, for a decrease of 1.3 cpl in its propane pricing schedule based on decreased costs:

  - a. Irving be in accordance with Appendix "A" to this Order;
  - b. Superior be in accordance with Appendix "B" to this Order;
  - c. Kenmac be in accordance with Appendix "C" to this Order;
  - d. Avenir be in accordance with Appendix "D" to this Order; and
  - e. Noonan be in accordance with Appendix "E" to this Order;
- 5. the propane prices approved herein shall appear on all invoices covering sales or deliveries of propane; and
- 6. the prices determined in this Order, with adjustments resulting from tax changes only, shall remain in effect until otherwise ordered by the Commission.
