**UPON** reviewing and considering current international, national and regional market and related conditions;

**AND UPON** it appearing to the Commission that:

- 1) There will be an increase in the regular gasoline prices currently in effect in both the dealer and consumer schedules of 3.5 cents per litre (cpl);
- 2) There will be an increase in the premium gasoline prices currently in effect in both the dealer and consumer schedules of 2.0 cpl;
- 3) There will be an increase in the diesel prices currently in effect in both the dealer and consumer schedules of 2.0 cents per litre (cpl); and
- 4) There will be no change in the furnace fuel and stove oil prices currently in effect in the consumer schedules;

will result in prices that are just and reasonable;

**NOW THEREFORE**, pursuant to the *Island Regulatory and Appeals Commission Act* and the *Petroleum Products Act*;

## **IT IS ORDERED THAT**

1. **the prices contained in the attached Retail Dealer Pump Prices Schedule shall be effective 12:01 a.m. on Friday, April 24, 2026;**
2. **the prices contained in the attached Maximum Consumer Petroleum Prices Schedule shall be the maximum prices charged by the respective licensee, effective 12:01 a.m. on Friday, April 24, 2026;**
3. **the attached dealer prices, with H.S.T. added, shall be indicated on all documents accompanying deliveries of these products; and**
4. **the prices determined in this Order, with adjustments resulting from tax changes only, shall remain in effect until otherwise ordered by the Commission.**

**NOTICE:****Section 58 of the *Petroleum Products Act* reads as follows:**

*58. Where any person has the status of a party or is an intervenor in any hearing before the Commission, he is entitled*

*(a) to appeal the decision of the Commission to the Court of Appeal; and*

*(b) to participate as a party in the hearing of an appeal.*

*and an appeal shall be on a question of law or jurisdiction only and be governed by section 13 of the Island Regulatory and Appeals Commission Act.*

**Subsections 13(1) and (2) of the *Island Regulatory and Appeals Commission Act* provide as follows:**

*13.(1) An appeal lies from a decision or order of the Commission to the Court of Appeal upon a question of law or jurisdiction.*

*(2) The appeal shall be made by filing a notice of appeal in the Court of Appeal within twenty days after the decision or order appealed from and the rules of court respecting appeals apply with the necessary changes.*
