Maritime Electric Company, Limited

2026 Annual Capital Budget

Maritime Electric Company, Limited filed its 2026 Annual Capital budget application with the Commission in November 2025. As a result, the Commission’s review of the application is occurring later in the calendar year than is typically the case for annual capital budget filings.

In its application, Maritime Electric is also requesting approval of certain capital projects in advance of the Commission’s final determination on the full 2026 Annual Capital Budget. The Commission will consider this request as part of its review of the application.

BACKGROUND

Maritime Electric is seeking approval of capital expenditures in the amount of \$102,642,000. The proposed capital expenditures are broken down as follows:

Transmission	\$ 38,225,000
Corporate	\$ 4,468,000
Capitalized General Expense	\$ 863,000
Interest During Construction	\$ 1,427,000

Net Capital Expenditures	\$ 102,642,000

In order to be considered, applications for intervener status must be received by the Commission no later than **4:00 p.m. on February 3, 2026**.

If the Commission determines a public hearing is necessary, a Notice of Hearing will be published. Otherwise, the Commission will complete its review of the application and issue a written Order on the application which will be posted on the Commission website at [www.irac.pe.ca/electric](http://www.irac.pe.ca/electric)
