Notice of Application

Maritime Electric Seeks Approval to Establish a Regulatory Deferral Account for Rotating Outages Operating Costs

Maritime Electric Company, Limited ("Maritime Electric") has filed an application with the Commission seeking approval to establish a regulatory deferral account to record operating costs associated with executing its Rotating Outages Plan.

Maritime Electric submits that rotating outages may be required during periods when electricity demand exceeds available supply in order to maintain system reliability. The Company is seeking approval to defer certain operating costs related to planning for and carrying out rotating outages, which were not included in rates approved in its most recent General Rate Application. Any costs recorded in the deferral account would be subject to review and approval by the Commission in order to recover these costs from customers.

In reviewing the application, the Commission will consider whether it is appropriate to establish the proposed deferral account and the terms under which costs may be recorded. At this time, this application is **only** to establish a deferral account. This is not an application to recover costs from customers.

Maritime Electric must respond to all written questions by **February 6, 2026**. All questions and responses must be filed with the Commission. All questions and comments received by the Commission will be made public and posted on the Commission website.

HOW TO INTERVENE

Any person or organization wishing to intervene in the application may apply to the Commission for intervener status. The application must be made in accordance with the Commission's Rules of Practice & Procedure. To be considered, applications for intervener status must be received by the Commission no later than **4:00pm on Friday January 23, 2026**.

If the Commission determines a hearing is necessary, a Notice of Hearing will be published. Otherwise, the Commission will complete its review of the application and issue an Order on the application, which will be posted on the Commission website at <https://irac.pe.ca/electric>
