In accordance with the Direction Regarding Procedure, issued by the Island Regulatory & Appeals Commission (the "Commission") on Wednesday, August 4, 2021, please accept this email as confirmation that D&L Crane Holdings Ltd. wishes to confirm its prior objections in relation to the Application.

The rationale for the objections largely remain the same as those noted in the correspondence sent to you by Mr. Crane on July 22, 2021.

With all due respect to the Applicant, both the Application and Response submitted on August 13, 2021 lack specific information and details that have normally been provided by an applicant when seeking to have a new petroleum license issued. Additionally, some of the statements made in the Response require scrutiny as to whether they constitute opinion evidence which can be adequately provided to, and relied upon by, the Commission in this Application.

The Commission has set out, through several prior decisions, what it expects an applicant to provide to satisfy the Commission that the public need, convenience, and necessity of a new petroleum outlet is in the interests of the motoring public, and several of those factors are not readily ascertainable based on the materials submitted to date. For those reasons, D&L Crane Holdings Ltd. confirms its objection to the Application.
