TAKE NOTICE that I/we hereby appeal the decision made by the Minister responsible for the administration of various development regulations of the **Planning Act** or the Municipal Council of Charlottetown (name of City, Town or Community) on the 23rd day of February, 2023, wherein the Minister/Community Council made a decision to Renovate an existing building to accommodate Drug Overdose Prevention Site just 20 meters from our back yard without consulting us or giving any assurance we won't have any interactions with drug addicts (attach a copy of the decision).

AND FURTHER TAKE NOTICE that, in accordance with the provisions of Section 28.(5) of the *Planning Act*, the grounds for this appeal are as follows: (use separate page(s) if necessary)

Locating a drug Overdose Prevention Site within 20 meters of our lifetime investment and home will devalue and stigmatise the property while making our lives fearful of using our back yard without getting into conflict with unruly individuals who are high on drugs and disrespectful to everyone.
